**AS SOUTH-CENTRAL WISCONSIN'S BUSIEST FOOD PANTRY, THE RIVER SERVED OVER 18,777 UNIQUE INDIVIDUALS A TOTAL OF 366,922 TIMES IN 2024. THIS INCLUDED FOOD-INSECURE CHILDREN, SENIORS, VETERANS, THOSE EXPERIENCING HOMELESSNESS, AND LOW-INCOME FAMILIES THROUGHOUT DANE COUNTY. WE PROVIDED OUR NEIGHBORS IN NEED WITH: OVER 3.5 MILLION POUNDS OF FOOD AND OTHER ESSENTIALS; 126,042 FRESHLY PREPARED TO-GO MEALS FOR ENTIRE HOUSEHOLDS TO ENJOY AT HOME; 59,301 MOBILE MEALS IN OVER 30 LOW-INCOME NEIGHBORHOODS; 3,122 GROCERY DELIVERIES TO THE HOMEBOUND; AND 1,778 ONLINE GROCERY ORDERS TO EXPAND CLIENT CHOICE.
